Added staff for helpdesk support and software development. Led several software projects to integrate internal systems for smooth work flow throughout a Wide Area network over Washington and Oregon. Provided for full, secure remote access for employees and secured the entire network with a Cisco firewall and Imperva SecureSphere WAF. Led the IT group through a full external audit with positive results. Developed security protocols for internally stored PII data.
